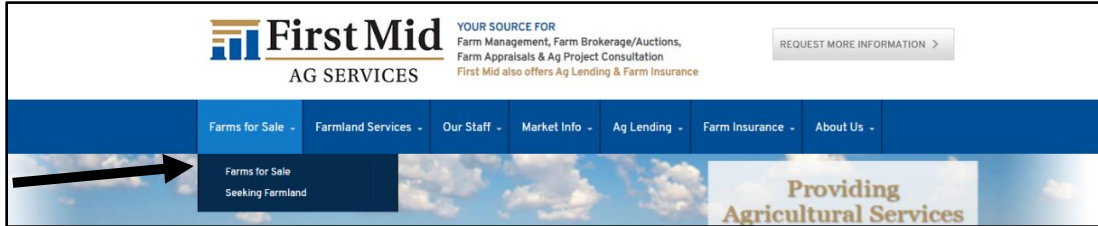


HOW TO REGISTER FOR AN ONLINE AUCTION

Farms for Sale



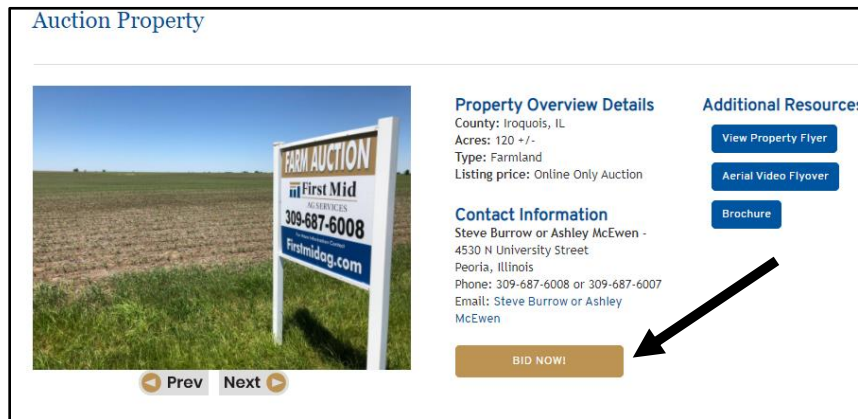
3. Navigate to the auction you are interested in viewing and select

4. Click on the

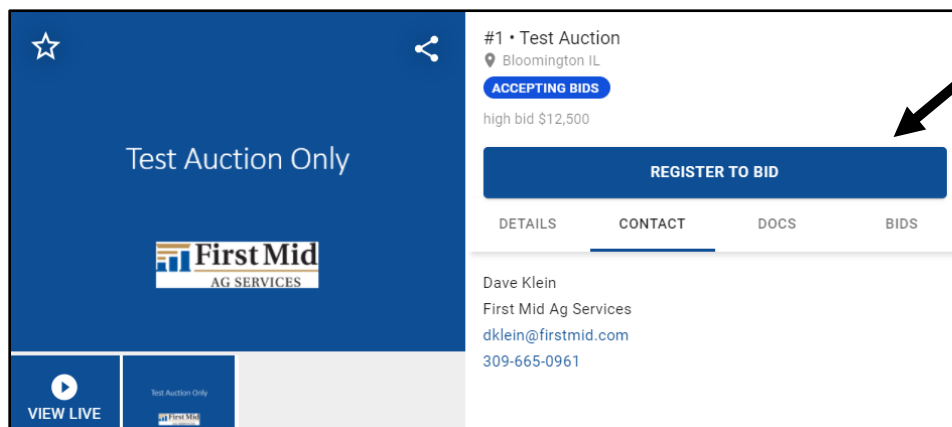

button.




5. From this tab select

REGISTER TO BID




6. To create an account, select [NO ACCOUNT? SIGN UP HERE](#). If you have previously created an account, you may enter your email address and password to sign in.




