

LEGAL DESCRIPTIONS

#1 - 45.93 Acres

Part of the West Half of the Northwest Quarter of Section 17, Township 10 North, Range 4 West, of the Third Principal Meridian, Montgomery County, Illinois.

More particularly described as follows:
